# **COOKIE DECLARATION**

#### 1. The use of cookies

<u>www.quattroplant.nl</u> uses cookies. A cookie is a simple small file that is sent along with pages of this website and/or Flash applications and is stored on the hard disk of your computer, mobile phone, smart watch or tablet by your browser. The information thus stored can be sent back to our servers upon a next visit.

The use of cookies is very important for proper operation of our website, but cookies whose effects are not immediately apparent are also very important. Thanks to the (anonymous) input of visitors we can improve the use of the website and make it more user-friendly.

#### 2. Permission for the use of cookies

Your permission is required for the use of certain cookies. We do this using the so-called cookie banner.

### 3. Types of cookies used and their purposes

We use the following types of cookies:

- Functional cookies: with these, we can make the website operate better and more userfriendly for visitors. For instance: we store your login details or what you have put into your shopping basket.

- Anonymised analytic cookies: these cookies ensure that an anonymous cookie is generated every time you visit a website. These cookies know whether or not you have visited the site before. A cookie is only created upon your first visit; in following visits the existing cookie is used. This cookie only serves statistic purposes. With it, the following data can be collected:

- The number of unique visitors
- How often users visit the website
- What pages users view
- How long users view a certain page
- At what page users leave the site

- Analytic cookies: these cookies ensure that a cookie is generated every time a website is visited. A cookie is created only upon the first visit, which is used during visits that follow. This cookie only serves statistic purposes. The following data can be collected, including:

- What pages you have viewed
- How long you stayed at a certain website
- At what page you left the website

#### 4. Your rights concerning your data

You have the right to inspection, rectification, limitation and removal of personal data. Besides, you have the right to object to processing of personal data and the right to transfer of data. You can exercise these rights by sending us an email to <u>info@quattroplant.nl</u>. To prevent misuse we can ask you to identify yourself adequately. If it concerns inspection of personal data linked to cookie, we ask you to send a copy of the cookie in question. You can find it in the settings of your browser.

#### 5. Block and remove cookies

You can block and remove cookies easily at any time using your internet browser. You can also set your internet browser to receiving a message when a cookie is placed. You can also indicate that certain cookies must not be placed. For this option, consult the help function of your browser. When you remove the cookies in your browser, this may have consequences for a pleasant use of this website.

Some tracking cookies are placed by third parties that show advertisements through our website (among others). These cookies can be removed centrally through www.youronlinecookies.eu.

Please be aware that if you do not want cookies, we cannot guarantee any longer that our website will work optimally. It may be that certain functions of the site are lost or even that you cannot visit our website at all. Besides, refusing cookies does not mean that you will not be shown any advertisements at all. It is just that the advertisements will not be geared to your interests anymore and may be repeated more often.

How you can adjust your settings is different for each browser. If necessary, consult the

help function of your browser, or click on one of the icons below to go to the manual of your browser immediately.
